Greetings,

I finally have some good news for you. All the committee work of the last 3-4 months is now bringing results. I would like to thank all those who have served on the Call Committee and the Safe Worship Committee. We now have a plan to move forward. I would also like to thank Pr. Barb Hegfors for her mid-week and Sunday messages. Her efforts have kept us grounded in the Lord and have given us hope for a brighter future.

- 1. We have received all of our supplies that were ordered pertaining to opening the doors for safe in-person worship.
- 2. The Safe Worship Committee has a plan to open worship safely. You all received that in the last newsletter. You will also receive the plan again before we open for in-person worship. This will come in letter delivered by the USPS and will be something that you can refer to before attending worship.
- 3. The Call Committee has negotiated a Term Call with Pastor Greg Anderson. He was ordained in 2005 and has a history of working with youth as well as members of all ages. We look forward to him joining us in October. He is currently serving the congregation in Soudan. He will continue with Soudan and with Our Savior's both on a part-time basis. There are no current plans to enter into any agreement with Soudan in any form, such as a two-point parish. The Term Call, in our case, will be one year. During the year, if either party is not happy, the call can be terminated with 30 days' notice. The congregation will need to approve Pr. Anderson's call after the Term Call is ended and the Settled Call is offered. There will be quarterly evaluations taking place with Pr. Anderson and the Mutual Ministry Committee in an effort to make things happen smoothly and avert any problems before they get out of hand. Usually at the end of the term, if both parties are satisfied, the Term Call becomes a Settled Call. A Settled Call is what we used to refer to as a regular call.

As it currently stands, we are planning to open the doors to in-person worship on October 11, 2020. The hour of worship will be at 10:30 AM. Pr. Anderson is doing worship in Soudan at 8:30 AM. There will be a need for volunteers to take temperatures and other tasks related to safe worship practices. There will also be a need for ushers to indicate to parishioners when they should exit after worship while maintaining social /physical distance and other tasks that ushers usually perform. There will be a special council meeting on August 25,2020 at 6:30 PM to approve all these contracts and plans.

Agenda for the evening:

- Discuss and finalize the financial package for our candidate of choice for a ½ time pastor position for a 12 month term; after the 1 year term if the pastor and our church are happy with the arrangement we can turn it into a called position.
- Set up a Mutual Ministry Committee who will work with the Pastor
- Discuss returning to worship

Discussions:

President Boback and K Baxter Chairman of the Call Committee presented all in attendance with revised financial packages for our candidate of choice, after discussion we found one that seemed to work. A motion was made by C Worshek to accept the financial package for the 1 year term ½ time position beginning Oct 1, 2020, 2nd by M Castle. Motion approved.

President Boback asked that we find members who would serve on a "Mutual Ministry Committee" who would work with the Pastor in getting to know the goings on of our church; those who volunteered are: C Worshek, D Maki, J Dickinson, T Honkola and M Boback.

Returning to worship was discussed and agreed on; we will be opening our doors for worship beginning October 11th our service time will be 10:30 am, our term Pastor serves a church prior to our service at 8:30 in Soudan.

A motion to adjourn was made by C Worshek 2nd by M Boback. Motion approved 7:45 pm.

The council asks for your prayers, guidance and support, that by our faithful service we will see faith abounds and God's kingdom increase. The council invites all members to attend council meetings. "You are our church" and your input is valuable. Council meetings are the 3rd Tuesday of each month at 6:30.


